

# IAABO LIFE MEMBERSHIP NOMINATION REQUIREMENTS & GUIDELINES

## (Effective May 2023)

### **Member Requirements:**

1. Be a registered member of IAABO at the time of nomination whose status as an Active Officiating (AO) and/or Active Non-Officiating (AN) member totals a minimum of 30 years.
2. Submit nomination packet by December 31st of the nominating year.
3. Have promoted and contributed to the growth, purpose and ideals of IAABO and to the welfare of the game of basketball in an outstanding way through service to their local area, district and state boards. (where applicable).

### **Support Material Guidelines:**

1. Nominations and necessary support material, properly completed, shall be submitted and approved by a local area, district, or state board (where applicable). If more than one nominee is submitted by a local area, district or state board such board shall prioritize the nominees.
2. Submitting board is required to verify nominees' years of IAABO membership with the Executive Director.
3. Signatures of the President and Secretary of the submitting board are required on the nomination form. If the nominee holds either of those two board offices another board officer shall attest the nomination.
4. Nominations and all necessary support material, including a current photograph of the nominee, shall be submitted to the Executive Director no later than June 1st for Life Membership consideration in that year.
5. Nomination(s) for Life Membership shall be considered on a yearly basis. Nominees not elected may re-apply with all necessary support materials being re-submitted.

### **Other Guidelines:**

1. A member may not submit a nomination for Life Membership in their own name unless their status is that of an Individual (I) member with no district, area or state board affiliation.
2. The Executive Director shall review and verify all nominations and support material then submit copies of such, along with any other pertinent information, to the Chairperson of the Life Membership Committee for distribution to the committee members.
3. No more than five (5) IAABO members, including the outgoing President, may be elected in any one year (with no restrictions to the number elected from any geographical area).
4. The names of the nominees approved and recommended by the Life Membership Committee will be submitted to the IAABO Executive Committee at the annual fall meeting and subsequently presented to the IAABO delegates at the annual spring meeting for action.
